Background

At the annual meeting of the Yilgarn Fire Control Officers of the Bush Fire Volunteer Brigades, held on the 11th October 2017, the Chief Bush Fire Control Officer (CBFCO) Cr Wayne Della Bosca resigned from his position.

The Bush Fire Advisory Committee (the Committee) moved that Renato (Ron) Burro, the current Deputy Chief Bush Fire Control Officer (DCBFCO) be nominated for appointment by Council for the CBFCO position. Mr Burro accepted the nomination.

If Mr Burro is appointed by Council, the DCBFCO North position previously held would be vacant. The Committee nominated John Roberts for appointment by Council to the DCBFCO position. Mr Roberts accepted the nomination

Section 38(1) of the *Bush Fires Act 1954* states:

"A local government may from time to time appoint such persons as it thinks necessary to be its bush fire control officers under and for the purposes of this Act, and of those officers shall subject to section 38A(2) appoint 2 as the Chief Bush Fire Control Officer and the Deputy Chief Bush Fire Control Officer who shall be first and second in seniority of those officers, and subject thereto may determine the respective seniority of the other bush fire control officers appointed by it."
