Background

Council is a joint sponsor of the Central and Eastern Wheatbelt "Be-Active Program" with WEROC Council's for approximately 15 years and whilst the current MOU signed in June 2009 is due for renewal, two of the six Council's have decided to withdraw support for the scheme.

Comment

The "Be-Active" scheme has been operating for fifteen years and involves the Council's of Kellerberrin, Westonia, Yilgarn, Merredin, Tammin and Bruce Rock.

There are four "Be Active" coordinators across the Wheatbelt that are supported by Healthway, the Local Governments and the National Heart Foundation, with the aim of increasing participation in physical activity across the community

Being active is a key requirement for good health and for achieving and maintaining a healthy weight. However, currently only one in four Western Australian adults are getting the minimum of thirty minutes of physical activity they need each day for good health.

The scheme was initiated by Healthway in October 1996 and continues to evolve with the changing face of sport and recreation in the region.

The scheme co-ordinator Mr Rodney Thornton has been a regular visitor to the Shire and has been active with the school, pool and sporting clubs , providing assistance with programs , visiting sports trainers and activities and the Council has in the past contributed approximately \$11,000 per year to the scheme.

The withdrawal of Merredin and Westonia from the Scheme will have an impact on both the overall cost to remaining members and the additional time available for the Co-ordinator. It is understood that the annual contribution from Merredin was \$11,000 and Westonia \$7,500 leaving an additional \$18,500 to be split between the remaining contributors.

Council has in the past indicated its willingness to be part of the MOU and now needs to formally decide if it is prepared to meet the additional cost in return for service, for the project to continue into the future with only four out of six interested Council's.

At this stage it is anticipated that the cost to each remaining Council would increase in the order of \$5,000 to \$6,000 per annum with a notional increase in hours available to this Council of approximately 170hours per annum.

Background

The Council has indicated its willingness to express an interest in Southern Cross being nominated for selection as a Primary Health Care Demonstration site and it is now necessary to formally review the matter and decide if this proposal is to be pursued.

Comment:

The Southern Inland Health Initiative (SIHI) has over half a billion dollars in funding to strengthen community health services including funding for the establishment of Primary Health Care Demonstration Sites (PHCD). The aim of the PHCD site project is to "provide safe, appropriate and sustainable health care into the future."

It is fairly obvious that the current hospital structure is a relic of bygone days when doctors lived in communities, performed surgery and utilised local operating theatres and specialist services such as day surgery and midwifery.

Today, it would be fair to say that no Government of any persuasion will be willing to invest the capital and operating funds necessary to deliver what had existed it the past. Not withstanding that there simply isn't enough medical staff, either doctors or nurse professionals willing and available to commit to such a model.

The Multipurpose Service initiative formulated over 20 years or more ago to maximise the economies of scale and management of health services by combining both primary health as well as aged care, also appears to be under threat, as being unable to deliver the services to the community that the Commonwealth aged care packages were designed to deliver.

The rural aged care/hospital model being promoted for today is to support ageing in the home, through appropriate levels of home and community care services. This is then augmented by General Practice clinics with visiting specialists and acute triage facilities for accident and emergency.

It is of concern to Local Government for some time that neither the Commonwealth nor WA Government have provided sufficient funding for GP services in communities and have increasingly shifted that responsibility to Local Governments, by default.

The PHCD Site is not be a panacea for all the medical service and funding needs of the community but it is an opportunity to rework the capital infrastructure to meet what can be identified as the future community demand for services. It will not however, be able to redress or reinstate the services that have been lost and in this regard there will most probably continue to be a gradual change to health service delivery and perhaps diminishing communities' best expectations.

Council has a strong financial and community interest in health services and provides substantial financial and other incentives to attract and retain a GP and Pharmacist in Southern Cross. With a growing population, both in terms of permanent residents and FIFO workers, it is important to ensure that the provision of GP services in particular, is clearly part of any future health service model. Similarly with an ageing population it is not acceptable to simply shut down current facilities and services without making provision for local services, either in the home or in some other fashion.

The MPS model has ensured that there is a 24hour emergency service operating in Southern Cross and that there are aged care beds available and in use, at times overflowing into the general hospital.

Whilst it appears that WA Health has concerns with the current arrangements and is suggesting that they are unsustainable and cannot continue, Council and the community, at this time are being asked to seek a PHCD site. In doing so there are concerns that the PHCD site model makes no provision for aged care and it would be unacceptable for the residents in the local facilities to be moved elsewhere.

There are therefore two possible alternatives, maintaining the status quo may result in a process of ongoing incremental changes to service delivery. The second alternative is to accept the proposal for a PHCD site model and work in a consultative way with the WA Health, SIHI staff, Wheatbelt GP practice and other service providers to try and develop new and more appropriate health facilities and a workable model of health care for this community into the future.

Whilst the second option is attractive, at present, given the uncertainty about the future aged care model, this may not be the time to take that step.

On that basis it is recommended that Council not proceed with the application for PHCD site until such time as WA Health identify a workable heath care model that address Primary, General Practice and Aged care. Further that negotiation of such a model should include the Council, Wheatbelt GP and other health care agencies.

Background

Tenders were invited for the annual supply and spraying of hot bitumen for the 2012/2013 Financial Year Road Construction Program. Bitumen required for the 2012/2013 Road Construction Program is for the Moorine Rock South Road, Bodallin North Road, Parker Range Road and Koolyanobbing Road.

It is estimated 337,795 litre of bitumen is required for 2012/2013 of which 217,255 litres will be sprayed in lots of above 25,000 litres and the remaining 120,540 litres will be sprayed in lots off between 10,000 to 25,000 litres.

Also included in the form of tender is a requirement for companies tendering to submit a cost per tonne to carry out pre-coating of 1400 tonnes of aggregate.

Comments

Under the terms and conditions of the tender document the cost per litre of bitumen is fixed for the duration of the acceptances of the tender until 30th June 2014.

Background

The Department of Mines and Petroleum (DoMP) has received an application from Richard Read & Associates Pty Ltd and Highscore Pty Ltd for approval to clear 61ha of native vegetation for the purposes of the construction of an access road and to carry out mining operations on their Miscellaneous Licence L77/226 and Mining Leases M77/581, 77/1246, 77/1250 respectively, west off Forrestania-Southern Cross Road, South Marvel Loch. See attached letter, aerial photograph, and location map.

Comment

Town Planning Issues

The abovementioned leases and licence areas are zoned "Rural/Mining" under the Shire of Yilgarn Town Planning Scheme No 2. Thus the construction of an access road and carrying out mineral production fit this zoning.

This area has had mining operations carried out over many years and is criss-crossed with exploration grids.

Development Issues

Mr Read has previously spoken to the Shire with regards to establishing an access road and a sand extraction pit on his mining lease. Mr Read has made application to the Department of Regional Development and Lands for permission to establish both on Crown land and has been advised that –

"... under the Mining Act, sand is regarded as a mineral over Crown land therefore Mining Act tenure is a requirement for sand extraction over Crown land. As such, no Land Administration Act tenure is required provided the Department of Mines and Petroleum (DMP) issues some sort of approval."

Attached is an aerial photo with proposed layout of the development on the site provided on 13th June 2012.

Environmental Issues

These leases and licence are situated within Jilbadji Nature Reserve 24049 "Conservation of Flora and Fauna and also includes Location 46 and the Dulcie Jean Tank. The Dulcie Jean Tank is a historical site and a tourist site which needs to be preserved and maintained as such.

We believe that the natural water flow in this area is to the north and east of the proposed development and thus there could be contamination from the proposed development via stormwater towards the Dulcie Jean Tank and nearby semi-permanent salt lakes.

There is concern that the area to be cleared is 61ha which is fairly extensive in area. The clearing of this land will likely increase the flow of stormwater across the land towards the Dulcie Jean Tank.

The Manager of Works has raised concerns that the area to be cleared butts up to the Forrestania – Southern Cross Road in two areas which could mean that any treatment or waste pits could be positioned where they extend up to and even encroach onto the road reserve, and there could potentially be leaching from the pits towards the road reserve adversely impacting on the road reserve. For this reason it is recommended that if this development proceeds that there is to be a minimum buffer area 50 metres wide fully vegetated with natural bush vegetation along the length of the Forrestania – Southern Cross Road and also around the boundary of the Dulcie Jean Tank site.

The reason for the minimum buffer is that in the past Council has at least twice found that leachate dams or tailing dams have encroached onto its road reserves – north-east of Bullfinch and also at Radio Hill Mine Site. Once this occurs and damage is done it is very difficult to reverse the situation.

Background

Ms Vivienne Piccoli has written to the Chief Executive Officer, Mr Jeff Sowiak, advising that upon taking up the position as Chief Executive Officer of the Shire of Yilgarn after Mr Sowiak has left the Shire's employment at the end of September 2012, prior to her moving into the house designated for the position which is located at 37 Taurus Street, Southern Cross that there are several items of work that would need to be carried out. See attached copy of letter.

Comment

Most of the items of work are considered minor maintenance items which can be carried out within the current budget allocation for this property.

The few items that would be considered outside minor maintenance items are:-

Building Improvements

- 1) Installation of a gabled double carport at the front of the residence to accommodate a private and possibly a caravan.
- 2) Installation of reverse cycle air conditioned in family room to cover kitchen and living areas;
- 3) Replacement of kitchen stove top.

Building Maintenance

1) Painting throughout inside of residence.

Council allocated a budget of \$11,320.00 for various maintenance works on this property. To date an amount of approximately \$5,830.00 has been spent, leaving approximately \$5,490.00 to spend.

The small minor maintenance work can be carried out within the remaining money allocation. If the requested inside painting was to be a "freshen-up" rather than a full re-paint, due to re-painting works having been carried out after Mr Peter Clarke left nearly 2 years ago, then this work may come from this money.

Money has been allocated in the current budget to replace kitchen cupboards with new bench tops and cupboards. The installation of a new bench hotplate can be included with this work. Installing a new bench hotplate will cost approximately \$700.00 installed.

Building Capital Items

Installing a reverse cycle air conditioned to cover the kitchen and living areas will cost approximately \$8,280.00 installed.

Installing a gabled double carport at the front of the residence will cost \$8,206.00 installed – quote from P Rafferty Builder.

For the proposed carport it is proposed to construct a four sided gable roof carport 6.6m x 6.6m x 3.6m high from the top of the concrete driveway to the bottom of the front support beam. This will mean that the building setback from the front boundary will be approximately 1.2m. See attached copy of block plan, and elevations, plus coloured photographs of the rear patio at Mr & Mrs J & B Williamson's home in Southern Cross which Mr Rafferty built and which this design will be based on.

If Council considers agreeing to the construction of the proposed double carport, then it must consider the following town planning issues and grant approval for the reduced setback from the carport to the front boundary of 1.2m.

Town Planning Issues

The land is zoned "Residential" with a density rating of R10. Under the Residential Design Codes (R Codes) called up under the Shire of Yilgarn Town Planning Scheme No 2, a carport is termed an "outbuilding", and should have a maximum area of 60 square metres. Generally carports, sheds and free standing garages should be in-line with or behind the front of the dwelling to provide an open aspect for the front of the lot, and to not adversely impact on neighbouring properties views of the street, or the general streetscape. However, in older developments where there is no access to the rear of the lot from the front street or a rear lane-way, *it is accepted that where no feasible alternative exists, the street setback area may be utilised for carports and unroofed parking spaces*. For "Residential" land with a density rating of R10 the front setback is 7.5 metres from the front boundary. See attached extracts from the R-Codes – clause 3.10.1 Outbuildings, Part 3.2 element 2 – Frontage Streets, and Carports and Garages, clause 3.2.3 Set Back of Garages and Carports, and Table 1 – General Site Requirements.

The R-Codes do allow Council to grant approval for carports with no walls/doors to be located forward of the front of the dwelling (see Part 3.2

element 2 – Carports and Garages, and clause 3.2.3) provided the width of the carport does not exceed 50% of the frontage at the building line and the construction allows an unobstructed view between the dwelling and street, right-of-way or equivalent.

In this instance -

- there is access to the rear of the lot via the rear laneway;
- there is an existing double garage attached to the front and side of the existing dwelling but the roller door heights will not accommodate the existing four wheel drive vehicle and may not be high enough for the future proposed caravan;
- the proposed carport will have no walls or door added to it;
- the view of the front yard will be impeded only marginally if at all;
- the width of the proposed new carport will not exceed 50% of the frontage of the lot.

If Council is satisfied that the proposed carport will not adversely affect the neighbourhood after considering the abovementioned points, then approval could be granted.

Similar applications have been approved in the past -

- ❖ Mr Malcolm Barrass was granted approval in May 2012 to erect a 6.0m wide x 9.0m long carport within the front setback of Lot 525 Altair Street, Southern Cross with a setback of 3.7m from the front boundary.
- ❖ Mr & Mrs Andrew & Donna Crafter were granted approval in April 2007 to construct a 53.6m2 carport with a nil setback from the secondary street boundary.
- ❖ Mr & Mrs Shaun & Kim Chrisp were granted approval in January 2007 to erect a 3.5m wide x 6.5m long carport within the front setback of Lot 194 Sirius Street, Southern Cross with a setback of 1.0m from the front boundary and 1.2m from the side boundary.
- ❖ Mr & Mrs Topliss were granted approval in November 2005 to construct a new 5.5m long x 4.1m wide carport within the front setback of Lot 856 Scorpio Street, Southern Cross with a setback of 2.9 metres from the front boundary.

Regardless of the previous approvals granted, each application should be considered on its merits.

Background

The Office of Appeals Convenor has written to Council that it is currently carrying out the consultation process under section 45(1) of the *Environmental Protection Act 1986* regarding the proposal from Cliffs Asia Pacific Iron Ore Pty Ltd to construct and operate an open cut iron ore mine and haul road at the Windarling Range W4 East Deposit, located approximately 130 kilometres north of Southern Cross. The Environmental Protection Authority (EPA) has nominated the Shire of Yilgarn as a decision-making authority in this matter.

The EPA has assessed the proposal and has provided a 9 page summary statement which deals with condition restrictions to be placed on this proposal if approved. The Office of Appeals Convenor is seeking Council's comments on this summary statement. See attached copy of the summary statement received, plus a location map.

Comment

The Proposal

Is to construct and operate:

- An open cut, above the water table, iron ore mine pit at Windarling Range W4 East Deposit, approximately 130 km north of Southern Cross clearing up to 27.5 ha in area of native vegetation including Rare Flora species *Ricinocarpos brevis*, Priority 3 flora species *Austrostipa blackii* and Priority 4 flora species *Banksia arborea*;
- A haul road to connect the mine pit to infrastructure located at the existing Windarling Range mining operations – clearing up to 0.5 ha in area of native vegetation.

The W4 East Deposit is estimated to contain 6.8 million tonnes of iron ore and the mine life is expected to be five years. The mine pit will be to a depth of 403 mAHD or approximately 100m below the current ground surface, and there will be no dewatering or the ore body.

Supporting infrastructure exists at the Windarling Range W3/5 Deposit, and will be shared with the W4 East Deposit. Waste rock from the W4 East Deposit will be taken to the existing W3/5 Deposit Waste Rock Landform, and to the W4 West Deposit mine pit which will be created following the mining of the W4 West Deposit, both of which have already been approved for this waste under the existing Ministerial Statements and the *Mining Act* 1978.

Cliffs' application to clear native vegetation is included in this proposal and there will not be a separate or another approach to Council regarding the clearing of native vegetation.

Flora Impacts

While the clearing of native vegetation and the construction and operation of the open cut mine will impact on a Rare Flora species, and Priority 3 and Priority 4 flora species, the EPA considers that the issue of vegetation and flora has been adequately addressed and the proposal meets the EPA's objectives for this factor, subject to the recommended conditions that address offsets and the management plans being implemented.

While stating this, the EPA has noted that with this proposal there will be a loss of approximately 1073 individual *Ricinocarpos brevis* plants which will take the total loss of population at the Windarling Range to 9,263 plants or approximately 51% of the known Windarling Range population, equating to approximately 38% of the known regional population. This seems a high percentage of one plant species to loose from an area and it will only increase with the potential for more mines to be opened in the Windarling Ranges.

The EPA proposes the following conditions in respect of managing the *Ricinocarpos brevis* species at the Windarling Range W4 East Deposit:-

Project A - Research Project

Contribute scientific understanding to the long term recovery and protection of sustainable population of *Ricinocarpos brevis* at Windarling Range.

- Minimum of \$640,000 over a 5 year period, commencing within 12 months of the finalisation of the research plan required by Condition 13-1.

Project B – Translocation trial of *Ricinocarpos brevis* individuals removed by the Windarling Range W4 East Deposit proposal. Identify the potential for R. brevis individuals to be translocated with the aim of preserving the number of individuals and the land term protection of R. brevis at Windarling Range. The number of individuals to be translocated will be subject to practicability considerations such as plant size, site accessibility, and the aims and objectives of the trial.

- Minimum expenditure of \$40,000 with timing to be determined by the translocation plan required by condition 13-2.

Fauna Impacts

The proposal will affect to some degree 254 vertebrate species of which 10 are of conservation significance:-

- Malleefowl (Threatened Species, Specially Protected Fauna);
- Rainbow Bee-eater (Migratory Species, Specially Protected Fauna);
- Fork-tailed Swift (Migratory Species, Specially Protected Fauna);
- Peregrine Falcon (Specially Protected Fauna);
- South-western Carpet Python (Specially Protected Fauna);
- Major Mitchell's Cockatoo (Specially Protected Fauna);
- Crested Bellbird (Southern) (Priority 4);
- White-browed Babbler (Wheatbelt) (Priority 4);
- Australian Bustard (Priority 4); and
- Inland Greater Long-eared Bat (Priority 4).

The EPA noted the proposal will not significantly impact on the abovementioned 10 vertebrate species, except for possibly the Malleefowl, as their habitats are widespread outside the W4 East Deposit proposal area. The proposal is also unlikely to have a significant impact on Short Range Endemic invertebrate species as they are widespread outside the proposal area. Other fauna likely to be affected by this proposal is the Tree-stem Trapdoor Spider (Priority 4 fauna species) but they are also found widely outside the proposal area. In summary the proposal can be managed to meet the EPA's environmental objectives for fauna, subject to conditions for the implementation of a Malleefowl Conservation Plan and the implementation of the Fauna Management Plan.

Mine Closure

The mined-out pit will be left as an open void following the completion of mining. As the mine pit will be above the water table it is unlikely that the void will fill with water to form a permanent lake. Abandonment bunding will be installed around the pit to prevent fauna from accessing the open void. This bunding will be within 10m of the edge of the pit, will be 5m in width, and 2m in height. Due to the steep sides of the mine it will not rehabilitated.

Waste rock from the W4 East Deposit will be disposed of at the W3/5 Deposit Waste Rock Landform and by backfilling the W4 West Deposit once mining there ceases.

The haul road will be fully rehabilitated with native vegetation from the area, including spreading of topsoil, subsoil and retained vegetation, deep ripping for improved soil condition and drainage purposes, and the spreading of local seed.
