Purpose of Report

To consider and adopt the Municipal Fund Budget for the 2017 / 2018 financial year together with supporting schedules, including imposition of rates and minimum payments, adoption of fees and charges, setting of elected members fees for the year and other consequential matters arising from the budget papers.

Background

The 2017 / 2018 operating budget has been compiled based on the principles contained in the Strategic Community Plan and Plan for the Future. The 2017 / 2018 budget has been prepared in accordance with the presentations made to councillors at the budget workshop held on the 22^{nd} of June 2017.

The rating structure proposed for the 2017/2018 financial year is predominantly unchanged from that imposed in the previous year. The exception to this is the "GRV – Rural" land category, where the intent is to raise an equivalent amount in revenue as that raised in the 2016/2017 financial year. Due to an average 10.22% valuation increase for this land category, the rate has been reduced to 1.7229 cents in the dollar from 1.9274.

The proposed differential rates for 2017/2018 where initially endorsed by Council during the budget workshop meeting. At this meeting, 3 submissions received were presented for discussion with the result that Council amended the following land categories rate in the dollar from levels previously endorsed as part of the 2017/2018 Rating Strategy:

GRV – Commercial - From 11.0120 cents in the dollar to 7.7518.

GRV – Mine sites - From 16.0000 cents in the dollar to 15.5036; and - From 20.0000 cents in the dollar to 15.5036.

Comment

The budget has been prepared to include information required by the Local Government Act 1995, Local Government (Financial Management) Regulations 1996 and Australian Accounting Standards. The main features of the budget include:



- The Schedule of Fees & Charges included as part of the Budget documentation were adopted at the May 2017 meeting of Council.
- General Rates will remain predominantly unchanged as indicated

It should be noted that 50% of the 2017/2018 Federal Assistance Grants were prepaid in 2016/2017.

Statutory Environment

Section 6.2 of the *Local Government Act 1995* requires that not later than 31 August in each financial year, or such extended time as the Minister allows, each local government is to prepare and adopt, (Absolute Majority required) in the form and manner prescribed, a budget for its municipal fund for the financial year ending on the next following 30 June.

Divisions 5 and 6 of Part 6 of the *Local Government Act 1995* refer to the setting of budgets and raising of rates and charges. *The Local Government (Financial Management) Regulations 1996* details the form and content of the budget. The 2017 / 2087 budget as presented is considered to meet statutory requirements.

The draft 2017 / 2018 budget has been developed based on the existing Plan for the Future and strategic planning documents adopted by council.
