### SHIRE OF YILGARN COVID-19 UPDATE

On behalf of Council I would like to sincerely thank all Yilgarn residents for their patience during the past month, particularly with the reduced Administration and Community Resource Centre office hours. Hopefully opening times can be increased in the near future based on the reduction in infection rates of COVID-19 throughout the State.

Council for the first time, conducted its March 2020 Ordinary Council meeting via teleconference in order to meet social distancing measures. Whilst not the preferred method to conduct meetings, it did meet its purpose and was successful in Council undertaking its normal decision-making processes. Future meetings may also be conducted in this manner and residents will be advised via advertising in Crosswords on a monthly basis.

With Federal and State Governments introducing a range of stimulus initiatives during COVID-19, Council at the above meeting also resolved a number of local initiatives to assist ratepayers and sporting and community groups in the district, which are as follows:-

### 2020/2021 Budget – Council Rates

Council has resolved that it will impose a <u>0% rate increase in the 2020/2021 Budget</u> based on last year's rates in the \$. All Western Australian Local Governments have been lobbying the State Government to also place a freeze on land re-valuations however, the State Government has stood firm on this matter and has instructed the State Valuer to continue with this process. Unfortunately this may affect the dollar amount of rates imposed.

### Community and Sporting Groups – 2019/2020 Fees and Charges Waived

Council has resolved that Fees and Charges imposed on community and sporting groups for the use of Council facilities for the 2019/2020 financial year will be waived and these groups will be receiving refunds in the coming months.

Should COVID-19 restrictions in the utilisation of Council facilities continue into the 2020/2021 financial year, Council will re-assess Fees and Charges imposed at that time.

### Waiving of Outstanding Rates Interest 1 March 2020 – 30 June 2020

To ease some of the financial burden on ratepayers, late payment interest calculated on outstanding rates has been waived effective from 1 March 2020 to 30 June 2020.

With the current declared state of emergency due to the COVID-19 pandemic and the present and ongoing financial and economic impact this has had on ratepayers, interest calculations on all outstanding rates, including those on instalments, has been waived for the remainder of the 2019/2020 financial year. Beyond 30 June, further consideration on Outstanding Rates Interest will be made in the 2020/2021 Budget deliberations



### Easing of restrictions / reduced services due to COVID-19

With the State Government's easing of certain COVID-19 related restrictions due to the lessening of the crisis in Western Australia, it has been decided the Shire Administration can recommence operations as well.

<u>Effective from Monday 4<sup>th</sup> May</u> the Shire of Yilgarn Administration will recommence full-service provision with the requirement to make a booking and limited opening days being removed.

Social Distancing of 1.8m and a maximum of <u>ONE (1)</u> patron in the Administration Reception at any time will be enforced. If more than one patron is in attendance, the additional patron/s will be required to wait outside.

### **General Update of Current Projects**

### New Southern Cross Swimming Pool Project

The project is progressing extremely well with the scheduled completion date being 12 November 2020. This date is subject to change as COVID-19 issues may affect supply of materials or if workers on-site are infected with the virus. Hopefully this will not be the case and all precautions are being taken in respect to these matters.

### New Constellation Park Playground

New Playground equipment is currently being installed at Constellation Park. This is the first stage of developments for Constellation Park, with a bike track, especially for smaller children, being proposed in the 2020/2021 financial year as Stage 2.

#### Yilgarn Recreation Centre – Asbestos Removal

This project is now complete after two stages. All asbestos sheeting on the roof and façade has been removed with a new metal façade replacing the previous one. New entrance signage is currently being planned and funds will be allocated in the 2020/2021 Budget to complete the look of the building.

#### Automatic Doors Installed at Southern Cross General Practice

Council has installed automatic entrance doors to the Southern Cross General Practice. The installation is very opportune at this time and alleviates the need for patients to touch door handles when entering the Surgery.

It is business as usual at the Shire, even if some of our inside staff are working from home. Our construction, maintenance and gardens personnel are undertaking their normal duties, albeit with some social distancing measures being in place.



### **Influenza Vaccination Program for 2020**

Annual Influenza vaccination is the most important measure to prevent influenza and its complications.

Government funded <u>under</u> 65 year old influenza vaccines should be available in the clinic from **around mid to late April all being well.** 

We already have stock of the <u>over</u> 65yo's. Appointments can be booked now for administration of the vaccine.

**Please note:** This year we have been advised that, vaccination can be done as soon as possible once we have stock of vaccines, no longer having to wait until May.

### Eligibility for government funded influenza vaccines in WA in 2020 is unchanged from 2019.

The following individuals in WA are eligible to receive government funded vaccine:

- persons 65 years or older
- children 6 months to less than 10 years
- pregnant women (any trimester)
- Aboriginal people 6 months and older
- individuals 6 months and older with medical conditions that place them at risk for complications of influenza, including:
  - cardiac disease
  - chronic respiratory conditions
  - chronic neurological conditions
  - impaired immunity
  - diabetes and other metabolic disorders
  - renal disease
  - haematological disorders
  - children aged 6 months to 10 years receiving long term aspirin therapy.

### Private influenza vaccinations:

We will be offering private flu vaccines for a small cost to those who do not meet the above criteria, and also for those companies who wish to have their employees vaccinated. Please contact the practice on 9049 1147 for appointment scheduling and further information.

### Help stop flu from spreading

Good hygiene practices, such as washing your hands thoroughly with soap and warm water can assist with reducing the risk of infection.



### COVID-19 (Corona Virus)

In light of current events relating to the COVID-19 situation, please maintain social distancing when you come to the clinic. The amount of people in the waiting room area at any time will only be 2, so please be prepared to be waiting outside, seats available, or waiting in your car parked outside the clinic.

Anyone with cold/flu like symptoms will be asked to wait in your car or seated outside. Please do not enter the clinic. You can pop your head in the door to let us know you have arrived or give us a call to say you are waiting.

Those people who have travelled overseas in the last 14 days, and, or have come into contact with someone who has tested positive to COVID-19 is asked to stay at home, isolate. Our doctor is happy to then carry out a phone consultation.

We hope to keep everyone safe and healthy as possible during this difficult time.

### Did You Know?

**Did you know** the Wheatley area along the Koolyanobbing road was once known as Tin Hill. This area was opened to farming during the 1920's.

However the Farmers Progress Association was unhappy with Tin Hill for a name, and voted on changing it to either Wheatley or New England. The votes were tied, so the chairman exercised his right to vote and chose Wheatley. In those days of a thousand acre farms there was dozens of farmers at Wheatley. They had their own hall which also doubled as a school.

The depression ended their dreams and most walked off, broke and disillusioned. Today most of Wheatley district is owned by the Guerini families and Della Bosca families.

Wheatley hall started its life as a cordial factory in Southern Cross. When farming collapsed during the depression, the hall was moved to Noongar for use as hall and school.

A few years later it was sold to a mining company and moved to Campion. It was common practise to recycle buildings.

- Respond to your child's reactions in a supportive way.
  Children may respond to stress in different ways such as being more clingy, anxious, withdrawing, angry or agitated, bedwetting etc.
- Children need adults' love and attention during difficult times. Give them extra time and attention. Remember to listen to your child, speak kindly and reassure them. If possible, make opportunities for your child to play and relax.
- Try and keep your child close to you and try avoid separating them from parents and caregivers. If separation occurs (e.g. hospitalisation) ensure regular contact (e.g. via phone) and re-assurance.
- Keep to regular routines and schedule as much as possible, or create new ones, including school/learning as well as time for safely playing and relaxing.
- Provide facts about what has happened, explain what is going on and give them clear information about how to reduce their risk of being infected by the disease in words they can understand depending on their age. This also includes providing information about what could happen in a re-assuring way.

- 2. Some cloud accounting packages have been updated and include a JobKeeper report which will help you identify which employees may be eligible if your business is

- 5. Confirm with eligible employees that they agree to you being the primary employer to receive JobKeeper Payments.

- 7. Keep the Employee Nomination Form on file (must be retained for 5 years).
- 8. Pay the minimum \$1,500 to each eligible employee per JobKeeper fortnight. The first fortnight starts on 30 March and ends on 12 April. Alternatively, you can make one combined payment of \$3,000 for the first two fortnights paid by the end of April 2020.
- 9. Enrol for JobKeeper from 20 April using the Business Portal and authenticate with MyGovID

#### 2020 NRM COMMUNITY STEWARDSHIP GRANTS NOW OPEN

The 2020 Community Stewardship Grants are now open for community-based projects that help conserve, restore, rehabilitate or enhance a local natural area, conserve WA's biodiversity and maintain or build the capability of NRM community groups across the State.

Local Member Mia Davies MLA has encouraged local groups to get their applications ready, and invited them to contact her office for support or assistance as they prepare their submissions.

"There are two categories available, small grants valued between \$1,000 to \$35,000, and large grants intended for more strategic, complex projects between the value of \$35,000 and \$450,000," Ms Davies said.

"Applicants being encouraged to apply include Landcare groups, Land Conservation District Committees, production groups, and 'friends of' groups.

"Aboriginal community organisations, Community Resource Centres, local governments, regional NRM bodies, primary and secondary schools and recognised biosecurity groups are also eligible."

Ms Davies said the funding allowed local groups to focus on key areas in their own backyards.

"This funding can help underwrite projects to tackle salinity, combat erosion, protect threatened species and eradicate pests and weeds," she said.

"It allows projects to be driven by local people who intimately understand the environment and natural resources of our region," Ms Davies said.

Ms Davies said groups interested in securing a grant should apply through the Natural Resource Management website – <a href="www.nrm.wa.gov.au">www.nrm.wa.gov.au</a>. Applications close on 15 June 2020.

Member for the Agricultural Region Martin Aldridge MLC said it was important that grassroots funding programs like the Community Stewardship Grants continued to operate during the COVID-19 emergency.

"Groups can be planning and securing funds for projects for when the restrictions related to COVID-19 are eased," Mr Aldridge said.

"Staying connected during these difficult times through shared interests and community groups is a good way to beat the isolation we're all experiencing at the moment."
